Before all this happened, there was a bit of encouraging news from the legislature. The Transportation Bond Bill proposed by the House had a 50% increase to the "Chapter 90" program. On the bright side, the delays that will undoubtedly occur in executing roadwork this year could be a pretty good argument for a multiyear "Chapter 90" program in the future. There is no logical reason to hinder or impede New England construction work over and above what we already face due to normal winter seasonal limitations and extreme weather. We need to have the funding in place and the plans ready to begin our projects in sync with the seasons. We need to find political solutions that assist us in accomplishing this goal. Trying to develop plans for a summer construction season, with as much uncertainty as this year, will be no easy task for any of us. The only good news is falling oil prices should help a little.

Even though we cannot meet in person, the Board and the Mutual Aid Committee are working to keep things moving forward. There may be some delays in training and rolling out the program to the county coordinators but hopefully we can get everything ready to go when we finally get the all clear to resume business as usual.

Our Annual meeting has been rescheduled to Thursday, June 25th. We will keep you posted if there are any additional changes. Until then, please stay safe. Thank you.

### House Ok's Landmark Transportation Bills before Covid Crisis

On March 4 and 5, the House voted to pass two landmark transportation finance bills just days before Gov. Charlie Baker declared a state of emergency in response to the COVID-19 pandemic.

The related bills would make substantial investments in transportation systems and infrastructure across the Commonwealth, including a boost for the Chapter 90 local road and bridge program. By vote of 150-1, the House approved an \$18 billion bond bill authorizing targeted spending on state and local transportation needs over 10 years. The House also passed, 113-40, a major tax bill projected to generate more than half a billion dollars per year in new revenue for transportation.

The House's bond bill would provide a 50% increase for Chapter 90, to \$300 million for a one-year authorization, a provision that was added by House leadership. Earlier versions of the bill, including the transportation bond bill filed by the governor last summer and those released subsequently by various legislative committees, would have level-funded Chapter 90 at \$200 million. An increase in state aid for local roads and bridges has been a top priority of the MMA for many years.

Before COVID-19 hit Massachusetts, Senate leaders had been planning to unveil their own transportation package. With state leaders now focused on the public health emergency, however, it is unclear when legislators will be able to return to transportation finance.

On March 5, members of the MMA Policy Committee on Public Works, Transportation and Public Utilities visited the State House to speak with legislators about the importance of Chapter 90 funding to maintaining and improving the 30,000 miles of roads and thousands of bridges that are the responsibility of local governments. During the visit, State House News Service interviewed the policy committee's chair, Mount Washington Selectboard Member Jim Lovejoy, and committee member and North Adams Mayor Tom Bernard.

"Bernard said at the current funding levels, it would take 73 years to repave every road in North Adams," State House News reported, "[while] Mount Washington, according to Lovejoy, receives about \$70,000 per year, according to the reimbursement formula, but faces costs of up to \$1 million to repave a single mile of roadway. 'For most communities, it's a lifeblood of funding for their municipal roads, Lovejoy said."

The single largest revenue source in the House's bill is a 5-cent increase in the state's gas tax, expected to raise between \$150 million and \$175 million. A 9-cent increase in the tax on diesel fuel would raise another \$32 million.

The bill would also raise revenue through changes to the minimum corporate income tax, fee increases for ride-hailing services, and elimination of a sales tax exemption for car rental companies.

A new special commission would study and make recommendations on the development and deployment of possible congestion pricing and variable tolling in the Commonwealth.

The revenue bill earmarks not less than \$160 million for the MBTA, \$15 million for regional transit authorities, and \$10 million for new rural transit assistance.

Gov. Baker has stated his opposition to proposals to raise taxes to fund transportation, specifically the gas tax, going so far as to say that he would decline to sign such a bill.

At the MMA Annual Business Meeting on Jan. 25, municipal leaders from across the state overwhelmingly approved a policy resolution on transportation that included support for an increase to the state gas tax.

The MMA resolution also aligns with other components of the House transportation package.

Around the time of the House vote, State House News reported that Senate leadership was planning to take a different approach, with an emphasis on policy over revenue and taxes. Senate Ways and Means Committee Chair Michael Rodrigues said, "We will let the policies dictate the revenues rather than let the revenues dictate the policy."

Despite a common understanding of the need to invest significantly in the Commonwealth's transportation systems and infrastructure, differences between the House and Senate could result in a long negotiation process between the two branches before the July 31 end to the current legislative session.

## MHA Mutual Aid - April 2020

The Mass Highway Association has made great strides reviving the Public Works Mutual Aid Program and developing processes which we can all use during an emergency or natural disaster. Five years ago, we successfully wrote, lobbied for, and received approval of State legislation which made it legal for us to aid other towns and cities, with our own municipal forces and equipment.

The latest efforts have been focused on recruiting mutual aid coordinators and designing a system where any municipality can contact their assigned County Mutual Aid Coordinator (CMAC) and request assistance. Mass Highway Association is providing training to the CMAC's so that they know the proper information to obtain when help is requested and how best to locate and assign mutual aid assistance. To organize and monitor assistance, both during and after an event, MHA has partnered with MassDOT and BETA Group to utilize the Mass DOT, GeoDOT software mapping system. We are very appreciative of the efforts from Tito Sanchez of BETA and Jose Simo of MassDOT who have been excellent partners in this development process and are allowing us to use the latest tools to keep our mutual aid system efficient and well run.

This year, MHA will be allocating a portion of the dues paid by all municipal memberships to fund the mutual aid program. This funding will provide for the equipment, training, education, and distribution of information, all of which is needed to make the program successful. Most importantly, on the 2020 dues form, we provided a space and asked each municipality to assign a person from their community to be the mutual aid contact. If you did not assign someone, or did not provide the up to date contact information, please email secretary David Lane, (dlane@ danversma.gov) with the name and contact information so that we can keep the mutual aid mapping and database up to date.

The working committee is planning to have a tabletop, virtual mutual aid event at the beginning of May. Following this, each community will receive instructions on how to request aid and how to offer mutual aid assistance.

The topic of the times: Coronavirus. Covid-19. It's everywhere. And the goal is to try to avoid it. How does the public works sector accomplish this when jobs require teamwork and exposure and interaction with the public? From office personnel handling transactions to the crews keeping the roads and infrastructure going, the challenges faced over the past month have been trying. There are successful ways to reduce the overall exposure within the Highway Departments and Public Works as towns struggle to keep up with the demands of the services in these contagious times.

Workforce reduction is one way some towns are thinning their crews to minimize the amount of interaction. Whether it is a staggered workday shift, or one week on and one week off, adjusting the workforce can allow for decreased congregation during times where employees gather. Some towns may reduce workforce by asking the at-risk employees to stay home during this time. Planning for continued reduction may warrant some towns to cross-train as many workers as possible.

One of the challenges with workforce reduction may be management of the projects throughout the town and job completion without the full staff. It will no doubt be difficult to sustain town services with a reduced staff indefinitely.

A temporary cure to not only accommodating workforce reduction but also to reduce the public interaction, may be to change the operations or the town services offered through the Division. Many towns are taking this route while we are amid this outbreak. Services such as bulky waste transfer stations and trench permitting may be closed or grossly scaled down; collection days are cancelled; park maintenance and street repairs may be put on hold.

A huge factor in reducing the spread of the virus when isolation is not feasible is through distancing. Social distancing has been the new buzzword, and for good reason. Respiratory droplets potentially containing the virus are expelled through cough, sneeze, and even spittle while talking and some can travel distances greater than six feet. By creating distance between employees, the threat is reduced. Distancing for Public Works looks different from town to town- some have eliminated the punch clock for now so as not to gather in one place. Others have limited the number of employees who can congregate in the break/ lunchrooms or locker rooms or closed these areas entirely. One person/ one vehicle is another measure that other towns are implementing.

Other ways to reduce infection include good ol' fashion hygiene: cover your mouth with your arm when you cough or sneeze, wash your hands regularly, do not touch your face, and sanitize your hands in the absence of washing (though wash hands at next opportunity to do so). Disinfecting commonly touched surfaces and equipment should be part of the cleaning routine. Tools and vehicles should not be forgotten in the cleaning operations once an employee is finished. And with new recommendations from the CDC that people should use a cloth face covering, the employees may opt to wear these coverings when out in public or working on a crew (please note that OSHA standards still apply to the use of respirators; however, loose-fitting cloth covering face masks of the type CDC recommends that resemble surgical masks, may not be considered respirators requiring medical evaluations or fit tests).

As always, when the DPW or any organization is faced with challenging times, it is important to stay as focused as possible on continuing safely. We cannot forget other aspects of safety as we focus on Covid-19 protection, though infection control must be in the forefront of our minds and incorporated in our present daily life right now. Equally important is the need to be prepared, whatever the emergency, and to understand our responses and resources. But that's a conversation for another day....

On January 15, 2020, Marcos (Tony) Ruiz was shot to death while filling potholes on the street in Lawrence. Mayor Dan Rivera said, "These are some of the hardest working city employees who often times do some thankless workpushing snow, picking up trash, picking up needles. To see a fellow employee, die in this manner is unsettling to say the

least. We want to put our arms around them, make sure they are safe, supported and loved and so they know they are not alone. The investigation by the Lawrence Police Department State Police and District Attorney's office is ongoing." The shooter was caught and is in custody. The legal process is continuing.

Members of Essex County Highway Association and the New England Chapter APWA Bereavement Committee coordinated a tribute to Tony.
