Mutual Aid at Work

City of Worcester DPW & Parks answered the call in Princeton

The Town of Princeton recently extended its thanks to the City of Worcester and its Department of Public Works & Parks for the Mutual Aid provided to their Town in September.

After experiencing significant flood damage throughout the northeast section of Town, the small town's Highway Department could not repair the infrastructure without assistance.



According to a letter sent by Princeton Highway Superintendent Benjamin D. Metcalf, "We requested mutual aid from surrounding Towns, including the City of Worcester. Worcester was able to send a 10-wheel dump truck along with three men for five long days. Patrick Sullivan (Sully), William Berg (Bill), and Paul Snape were three of the nicest, most helpful guys you could have sent. They performed above and beyond what the small Town of Princeton could have expected. The two operators on the first day, in the rain, had to direct traffic and perform labor duties such as swinging a shovel around and running a plate whacker for compaction. Not one complaint from either Bill or Paul. All three gentlemen worked nine-hour days in Princeton. That does not include the time it took them to drive from Worcester and back each of those days. I am guessing they worked, at a minimum, 10-hour days for Princeton. You could tell they just wanted to help as much as possible, and they did. The rest of the week they operated some of our newer equipment, 305 Cat excavator, Cat Loaders and even a Backhoe. Bill and Paul are great operators and completed the difficult tasks like removing tons of roadway debris, gravel road repairs, digging and setting catch basins and drain lines, fine grading for pavement, and filling in washouts on our shoulders in various locations. Patrick was an excellent driver as well. I didn't get one complaint for speeding!! We would give him an address or intersection and he would have his truck there in minutes. I don't think he ever got lost. Sully had a great attitude as well. You sure sent some friendly guys. The Town of Princeton cannot thank you enough for your generosity and compassion the City of Worcester has for all surrounding Towns, not just Princeton. I hope this never happens again to any surrounding town or city, but if it does, Princeton will be there to help in any way possible. The City of Worcester is lucky to have such a great group of employees that go above and beyond. Thank you, Bill, Paul, and Sully, you made myself and the crew here in Princeton laugh and smile while working long days in some crummy weather!"

Mutual Aid sent by Holden, Sterling, Hubbardston, Westminster, and West Boylston DPWs

On the morning of Tuesday, September 12th, Ben Metcalf, Princeton's Highway Superintendent reached out to Holden Department of Public Works for help in responding to their flooding emergency. That day, Holden sent two 10-wheel dump trucks, a front-end loader, and a rubber tire excavator, along with a foreman and three crew members. Holden's Supervisor of Operations and Director of Public Works also responded that day, and they worked with Ben in performing additional damage assessment and acting as a planning coordinator for Princeton. Additionally, MassDOT, acting through MEMA, provided several dump trucks, variable message boards, and a number of cones and barricades on that Tuesday.

After getting a full damage assessment on the day after the flooding, additional calls for public works mutual aid were sent to the Towns of Sterling, Hubbardston, Westminster, and West Boylston. Each of these towns provided a 2-3-person highway crew, dump trucks, and/or backhoes for working on culvert repairs, dirt road regrading, roadway shoulder repairs, and roadway paving repairs. The Town of Holden's crews and equipment remained in town all week through Friday, September 15. Sterling's crew was onsite on Wednesday, September 13, Hubbardston's on Thursday, September 14, and West Boylston's and Westminster's on Friday, September 15. In response to the request for public works mutual aid through the Mass Highway Association, via the Worcester County Mutual Aid Coordinator Scott Crisafulli of Milford, the City of Worcester committed to providing a crew with operators and trucks each day for the week of September 18. MEMA and MassDOT also worked to provide private road contractors for Princeton from their state contracts.

The crew and equipment time was all logged and tracked, with the hope that federal disaster aid reimbursement will be forthcoming.

Using public works mutual aid, Princeton was able to increase the size of their emergency response and expedite their recovery process in the process.

This year we had the single axle truck event and a wheel loader event for the competition. Thank you for making this year our largest event to date as we had 29 loader operators, and 29 truck teams compete. It was very competitive and helped build comradery among the competitors, along with great peer interaction.

MHA and the County Associations have some of the best vehicle pre-trip vehicle inspectors, written test takers, loader operators and snowplow drivers. Your cities and towns should be proud, as they have trained you well.

I would like to thank all the teams and the cities and towns they represent for their participation in this training event as we would not have the event without you. The judges and the cities, towns, state agencies, vendors that you work for are a key component to making this event happen and run smoothly and efficiently. I would also like to thank our vendor sponsors and towns that helped us get the loaders and trucks we use for the testing event, and to Baystate Roads Program for handling the registrations and advertising, as this helps us greatly with our event.

2023 MHA results:

Single Axle Truck: 1st Town of Shrewsbury, 2nd Town of Yarmouth, 3rd Town of Concord;

Wheel Loader: 1st Town of Concord, 2nd Town of Shrewsbury, 3rd City of Newton

We travelled to the Western Snow and Ice conference on September 27th - 29th and competed at the national finals. The competition was tough this year with the largest field of competitors, 395, from across the country.

Here are the results:

Single Axle Truck - 24th out of 53 teams

Ten Wheel Truck - 5th out of 59 teams

Wheel Loader - 5th out of 100 teams

Skidsteer - 24th out of 68 teams

Motor Grader - 16th out of 58 teams.

The MHA team competed in the overall team for the day by competing in all 5 events and finished 3rd out of 23 teams.

Other New England team finishes:

NE APWA Manchester, NH Single Axle Truck 15th; RI Public works Single Axle Truck 31st; Portland, ME Single Axle Truck 34th. Great job by all.

Lastly, thank you to the MHA Board of Directors for their continued support of this training event financially by making it possible to take the winners to the National Finals in Colorado and to represent Massachusetts.

We look forward to seeing you at next year's Driver Skills and Safety Training event which will be held on July 17th, 2024.

Massachusetts Municipal Association (MMA) Fall Update

As we all prepare for the coming winter season, the legislature is bustling with action and [MMA's new Executive Director Adam Chapdelaine](#) is settling in. Adam is a past president of the MMA and seasoned municipal leader. He joins the MMA with considerable public management experience, understanding of the public policy environment, and deep knowledge of the policy implications of climate change. We are excited to start a new chapter with Adam at the helm.

Since the last newsletter, the Governor signed a [\\$56 billion state budget bill](#) for fiscal 2024 that increases unrestricted local aid by 3.2% over fiscal 2023 and boosts Chapter 70 education aid by \$603 million. The budget also allocated supplemental funding for municipal roads and bridges. In all, we are celebrating the approval of \$325 million in funding over the past few months that specifically supports municipal roads and bridges.

A transportation bond bill was signed on August 4 that included \$200 million for the Chapter 90 program as well as \$25 million each for 7 grant programs. Most notably, \$25 million was authorized for a new supplemental municipal road formula program to support rural communities. The formula for the additional \$25 million authorized in the bond bill will be calculated based on road miles, population, and whether a municipality is considered rural (population below 10,000 and population density below 500 people per square mile).

The bond terms for this new authorization were set along with the terms for Chapter 90, but it may take several months for this new rural road funding to be available to communities. MassDOT must create a new formula, submit it to the Joint Committee on Transportation, and await guidance. The Transportation Committee may decide to hold a public hearing on the proposed formula.

The state budget, signed by the governor on Aug. 9, includes \$100 million for local road and bridge maintenance funded by revenue from the voter-approved surtax on annual incomes over \$1 million, which, by law, must be spent on transportation and education programs.

The \$100 million allocated in the state budget will be for a Municipal Partnership Program to support municipal road and bridge projects. At least half will be distributed based on road miles, with the remainder distributed based on the Chapter 90 formula. MassDOT has until next March 1 to provide preliminary notice to communities about their apportionment of this funding (similar to the typical Chapter 90 notifications).

The Municipal Partnership Program is statutorily intended to mirror the Chapter 90 program in terms of process and restrictions. The funding will be available as reimbursements and will likely require similar administrative processing of projects.

In addition to the \$325 million made available for municipal formula funds, bond authorizations for six additional grant programs were included in the transportation bond bill. Each program was authorized an additional \$25 million. Authorizations included the following multi-year accounts:

- Municipal Pavement Program
- Municipal Small Bridge Program
- Complete Streets Funding Program
- Municipal grants for infrastructure focused on the enhancement of mass transit by bus
- Funding for the study, design, construction or improvements that increase access to mass transit and commuter rail stations
- Grants to municipalities and regional transit authorities to support fleet electrification

In other transportation news, MassDOT is in the process of creating a municipal grants portal that would allow a one-stop application to all

MassDOT grant programs. The agency anticipates launching the portal next April. Look out for details on this as spring approaches.

Beyond the good news of additional funding for roads and bridges, we are in the midst of hearing season. Alongside municipal officials, the MMA is busy testifying in person and in writing on a number of bills including S. 1589, *An Act relative to the use of green lights for municipal emergency management vehicles* and S.2107/H.3156, *An Act relative to municipal authority in public rights of way*.

[S.1589](#) would allow for departments of public works to use green strobe lights on department vehicles for DPW operations. Blair Crane, DPW Director in Norfolk, and Kevin Collins, Assistant Director of Public Works in Westminster, offered testimony in support of the bill.

[S.2107](#) and [H. 3156](#) would address the issue of double poles by allowing municipalities the ability to remove double poles, charge utility companies for the removal, and enact fees and taxes. Yarmouth's DPW Director and Mass Highway board member, Jeff Colby and Athol's Environmental Compliance & Asset Manager, Jennifer Shaw and Assistant Superintendent of DPW Paul Raskevitz provided testimony detailing the issues that arise due to double poles and how this legislation would provide relief.

If you are interested in testifying on a particular bill or issue of interest to you, please be in touch. I always want to know about your priorities.

Finally, special thanks to Dave Desrosiers, Granby Highway Superintendent and Mass Highway board member; Randall Kemp, Southampton Highway Superintendent; Mike Hale, Gloucester Dir. of Public Works and Mass Highway board member; and Steve Rolle, Worcester Commissioner of Transportation & Mobility for serving as panelists at a special State House briefing event on October 17.

In collaboration with Representative Michelle Ciccolo, the event was intended to celebrate new roadway funding while also providing information to legislators and their staff about state grant programs including Chapter 90 and the importance of these programs to municipal roadway needs. The audience heard from MassDOT Highway Administrator Jonathan Gulliver about DOT projects and key grant programs, and a panel of municipal officials who provided an overview of roadway operations and financing of projects in their unique municipalities.

There's much more ahead in the coming months as the legislature wraps up its year on November 15 and MMA prepares for our [2024 Annual Meeting](#). Registration is open! We hope to see you there on January 19 and 20.

Safety Corner

Free Safety Development and Training Resources

It has been almost six years since the Commonwealth of Massachusetts expanded compliance with the OSHA laws in the municipal sector. In 2014, by statute, Massachusetts authorized the DLS to provide State workers with at least the level of protection from workplace safety and health hazards as protections provided under the OSH Act by Federal OSHA (M.G.L. c. 149, § 6 1/2), and was then expanded in 2018 to include all municipal workers. Through continued outreach initiatives, training, and encouragement, towns were made aware of this adoption and the expectations for safety. As a private safety consulting company, we continue to encounter clients who are unfamiliar with the resources and responsibilities of the safety laws.

To provide a very general, simplified overview of what the safety expectations are, municipalities should ensure they are satisfying the following:

- **Identify the hazards** of the tasks their employees are expected to take on (example: flying debris from leaf blower could injure eyes, lacerate skin; loud noise from blower could damage hearing; job location may bring worker around traffic; etc...).
- **Determine what safety precautions/ controls** should be put in place to protect them from injury (from leaf blower example: wear safety glasses and long pants and boots, hearing protection and hi vis clothing).
- **Train employees** in the specific hazards and subsequent safety precautions (continued example: ensure workers know how to hold blower, turn it on, angles to use it in, how to use all the PPE properly, to be aware of the traffic, how to fuel, etc...).

Identification can be done through the use of safety policies and inspection checklists; precaution measures can be unique, but most are typical, and guidance can be found in multiple documents for support. Training can often be overthought; many topic presentations can be and should be on-the-job conversations about task safety, and we need to effectively train our employees on the specific tasks they are expected to perform.

Resources for all the above-mentioned support documents have already been developed for guidance and use. Many people do not take advantage of the tools that are available to them. Understandably, it can be daunting with the large amount of compliance tasks for safety alone- but putting together an overall plan for safety is a start.

The following are links to policies, inspections lists, training support fact sheets, and training material that can all be used to support the municipal sector in the safety journey:

If this is still a daunting task to begin to tackle, Mass DLS also offers free consultations. Alternatively, your insurance/ insurance group may offer guidance and support on safety efforts and the Massachusetts Department of Industrial Accidents offers grants annually for towns to provide safety training for their employees (<https://www.mass.gov/workplace-safety-grant-program>).

With the plethora of resources available, continuing the efforts of developing a safety program in your department can be attainable.


